
On 27th November 2021 Grievance & Redressal cell meeting was held at 3 p.m after pandemic. Everybody greeted & discussed the agenda with following members.

6th Meeting of Grievance & Redressal Cell (17/12/2022)


A meeting of grievance & redressal cell was held in the meeting room to discuss the following agenda with the following members


- Agenda - ① Counselling with the students
② Grievance related to the canteen



The convenor greets all the members to the meeting & read out the last meetings minutes. The members were asked about the canteen issue.




Another complaint is found orally that are unable to their sessional test


during practical exam. Hence, it is decided to conduct Term-End exam after finishing their practical exam which is suitable for the students.


The chairperson also informs the teachers about the students opinion regarding laboratory in the college


which was already discussed the matter with the president of the college. He assured that the condition would be developed within a short period when the boundary walls would be painted & glass filled.




